

# Privacy Policy

## 1. Your Privacy: Overview

This privacy policy (this "Privacy Policy") tells you about the information that AppCollection LLC. ("AppCollection LLC", "we," "us" or "our") collects in connection with the operation of its website, <http://app-collection.com/> (the "Site"), how the information is used and how you can access and correct certain information that we may collect.
